WEDDING DAY

On the wedding day, the hair & make up will be done following a schedule. Bride will be sent a timeline for the "day of" via email that she must approve prior to the wedding day. The bride must communicate the importance of being on time and properly prepared to her bridal party. _____(initial)

Make sure hair is prepared correctly. When in doubt, clean and dry is preferred, but how the state of how hair should be is usually discussed before the "day of" between bride and stylist. Blow drying is NOT included in the "style" unless prior discussed and agreed upon. _____(initial)

The Bride must confirm and commit to the number of services stated above. Charges will include all people stated above. _____(initial)

The stylist needs a designated space to set up when on location. The bride is responsible for clearing an area before the stylist arrives. The stylist will need a work area with a chair near an outlet in a no walk-through traffic area. Good light and a mirror is a plus! Please make sure the location has adequate lighting, ventilation, and electrical supply prior to day of. _____(initial)

Know what you want! Bring pictures of ideas that you are comfortable with. Time does not allow for "trials" on the day of the wedding. _____(initial)

PHOTO RELEASE AGREEMENT

CONTRACT TERMS

A minimum of 50% of the bride's total balance is required to reserve & book the wedding date. Due to the nature of the business your wedding date will not be scheduled until a deposit is paid and a contract is signed & received. Your deposit will be deducted from the wedding day total balance, which will be due on your wedding day. The day of your wedding I will accept cash or credit card.

FEES

A \$150 holiday fee will apply to weddings scheduled on nationally recognized holidays (example: New Year's Eve or Valentine's Day). A \$150 Sunday fee will apply to weddings scheduled on a Sunday. _____(initial)

A mileage fee only applies for locations over 20 miles from the Style House Salon (located at 7127 Main Street in Frisco TX 75034) to the location where services will be rendered. _____(initial)

0-20 miles: Free

20-35 miles: \$50

35-50 miles: \$100

50-65 miles: \$150

65+ miles: *TBD (Must be discussed and approved by stylist)

CANCELLATION POLICY

Cancellations can be made up to 30 days before the wedding day and you will be refunded 100% of your deposit within 60 days. If you cancel 30 days prior to your wedding day your 50% deposit will be kept in full and is non refundable. If you cancel within 2 weeks or less of the wedding day you will then be charged 100% of the total wedding day rate quoted.
